The Fundamentals

- **Restricted Funds** – Non Discretionary use, Donor specific
- Building Fund, TIA, Mission Mexico, St Vincent de Paul, Refugee program, special collections etc

- **Non Restricted Funds** – General collections, discretionary use
- Church operations, administration, programs

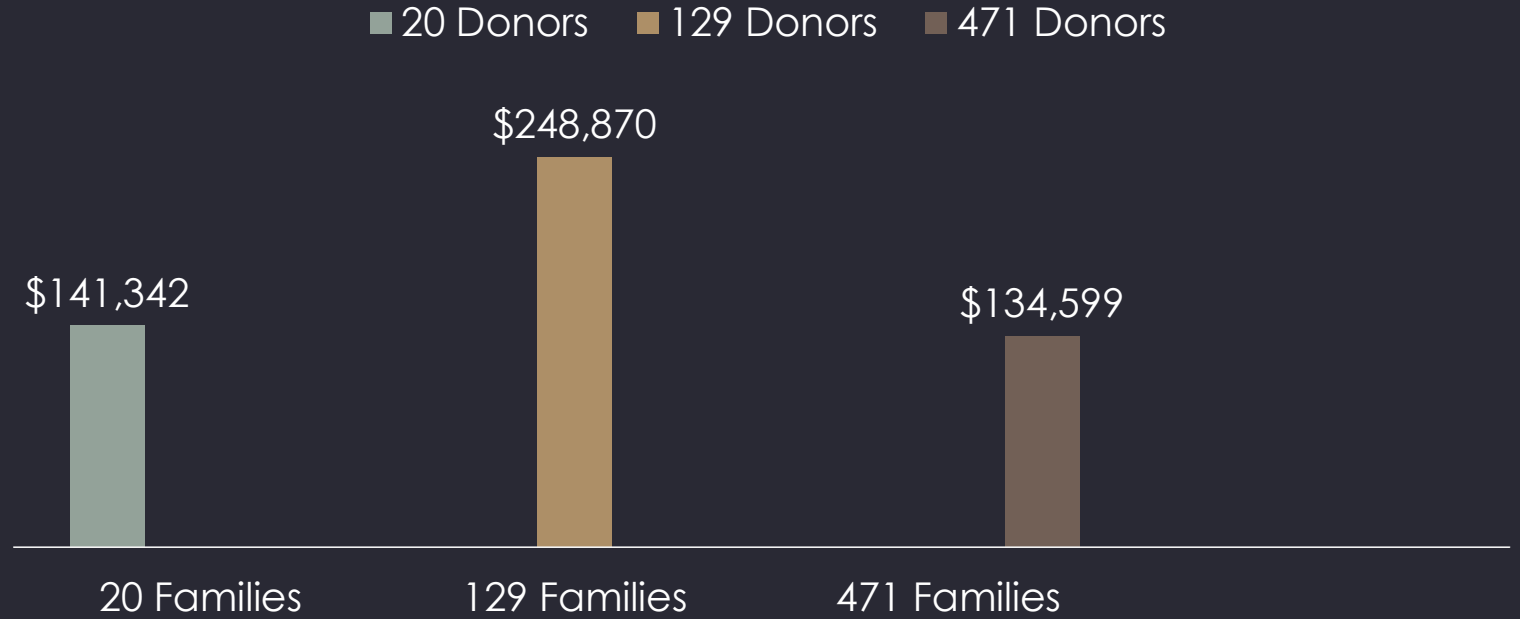
How is TIA Determined

- “Together in Action” is a contribution by each parish to fund the Diocese of Calgary’s outreach programs (locally, nationally and internationally)
- Based on St Gerard’s Assessable income as a percentage of the Calgary Diocese’s assessable Income
- St. Gerard’s 2017 % was 2 ¼ % or \$41,000

Determining “Assessible Income”

- Based on annual budget and used to fund Diocesan operations
- General collections (“discretionary funds”) less certain deductions eg. prog. supplies, welfare, Bequests are Non-Assessible
- A rate of 14.5% is applied against the Assessable Income
- 2017 amount is \$71,000
- 2018 budget amount is \$65,000

Donor Statistics – 620 Tax Receipts





Donor Statistics – 620 Tax receipts

- 20 families annual average - \$7,050
or **\$136 per week**
- 129 families annual average - \$1,929
or **\$37 per week**
- 471 families annual average - \$285.
or **\$5 per week**
